# Indoor Conservation Rebate Program

### **How to Apply**

Submit all completed and signed application with supporting documents as applicable to:

SBMWD Rebate Program PO Box 710 San Bernardino, CA 92402

After receiving an SBMWD pre-approval in the form of a "Rebate Number", purchase and install the water saving product as listed on the application. Any changes in products or materials as originally listed on the application must be approved in order to qualify.

To receive your rebate submit:

• SBMWD Debate Applie

- SBMWD Rebate Application with rebate approval number(s)
- Original receipt for approved water-saving item
- UPC Barcodes from product packaging

(Receipts must be received within 90 days of pre-approval date. If receipts/invoices or request for extension is not received within 90 days, amount allocated for rebate will be redirected back into available funds and additional rebate application is required)

Reimbursement will be issued in the form of a check or credit to customer account.

#### **Terms of Agreement**

- Applicant must be either the customer of record or legal owner of property within SBMWD water service area.
- Application must be approved before any purchase is made in order to qualify for rebates.
- If requested, applicant must provide reasonable access to property for verification of product installation.
- All SBMWD accounts must be in good standing with only current balance due.
- Application must be completed, signed, and requested supporting documents must be included for eligibility.
- Applicant must provide SBMWD with the original itemized and dated sale purchase receipt. If the price for any of the products includes installation and/or labor charges, the purchase and installation/labor must be listed separately on the original receipt.
- SBMWD reserves the right to refuse reimbursement if purchase cannot be verified.
- Failure to install the new equipment at the services address as listed on the application will result in the value of the rebate being added to the applicant's water bill.
- The applicant has full responsibility for complying with all applicable laws, municipal codes, ordinances, and permits.
- Receipts/invoices must be submitted within 90 days of pre-approval date. If not received within 90 days, amount allocated for reimbursement will be redirected back into available funds and an additional application will be required.
- Rebates are awarded on a first-come, first-served basis, given all program requirements are met. Rebates will be available for only as long as funds are available.
- Rebates listed are intended for SBMWD residential water customers. Commercial water customers may
  qualify on a case-by-case basis. Please call regarding rebate information for commercial or multi-family
  properties.
- SBMWD is not responsible for faulty equipment or installation of products, and does not represent the customer, retailer, or manufacturer of reimbursed materials in any dispute.
- Program rebates totaling \$600 or more per calendar year may be considered taxable income. If issued, applicant must submit a W-9 form to SBMWD in order to receive reimbursement. Consult a tax professional for your specific filing requirements.
